The aim of the project is to recognise and celebrate the 75th Anniversary of VE Day over the weekend of 8th to 10th May 2020 with events provided for participation by all Broad Town residents. This will coincide with the VE Day Anniversary bank holiday weekend.

The Group will aim to bring to the fore a strong focus on local and national history at the time of VE Day using costume, dance, food and displays.

Additionally it is intended that the legacy of the weekend will be the reinstatement of the annual Broad Town Show and a reinforcement of support for the assets of Broad Town: the White Horse, the Village Hall, the Church building, the School building and the Redhills Play Park.

The Broad Town Village Show has agreed to provide funding for the majority of the events.

A volunteer sub committee has been set up to manage the organisation of the events. There is a list of additional volunteers to manage and organise the individual events for set up, during the event and clear up.

The village hall has been booked for the weekend and a band, a singer and a fish and chip van for the evening dance have also been booked.

The Church representatives have agreed to hold an evening dedication service and also arrange the scarecrow competition.

The school has expressed an interest in participation, to be confirmed.

There will be events for all members of the community in Broad Town including school children, residents, church members and groups that use the village hall:

A free traditional family street party;

The village show will have competitions for all ages;

A family evening dance;

A free lunchtime event with singing;

Free viewing of the scarecrow competition;

Family church service.

There have been no larger scale community events in Broad Town since 2018 and this is an opportunity for newer members of the community to meet their neighbours.

The events will encourage pride in Broad Town and showcase its facilities to the community. In particular the event is intended to focus on the continuation of a regular community event.

Families, friends and neighbours will have an opportunity to spend the day together in celebration of a national event without the worry of costs and without having to travel outside of Broad Town.

Previous similar events have been extremely well received and successful and have brought the community together.
